Program Updates - Ben McCament (update given by Amy):

- Have not printed LRC AMDAT, will have Loretta working on it in the following weeks.
- ODOT agreement with DMRM for MiR funding @ \$310,200-signed and fully executed.
- Received Flint Run and MiR II OSM grant agreements from OVRCD-will be sent for signatures by the Director this week.
- ODNR is changing rules that allow coal companies to perform off-site mitigation (USACE and OEPA already allow this through 404 and 401 Clean Water Act permits).
 - Chief of DMRM has created an internal off-site mitigation workgroup and AML staff is working on developing projects that could make possible mitigation projects.
 - This would provide funding for the project and potentially long-term operation and maintenance funding. *Many issues to work out on this topic* (i.e. long term protection with easements/ownership/funding/etc.)....but developing situation with requests already coming in for Eastern Ohio.
 - Could be potential in Raccoon Creek with both Rhino and Waterloo operating in the watershed.
